Dear Safe Environment Training Applicant:

Thank you for your inquiry regarding applying to become a Safe Environment Trainer with the Roman Catholic Diocese of Phoenix.

Criteria to be considered a Safe Environment Trainer

- Must have completed the Foundation Class “Protecting God’s Children”. If you have taken the Foundation Class more than a year ago, we ask that you consider retaking the Foundation Class prior to training.
- Current in their Safe Environment Training Classes.
- If a registered volunteer at one of the Diocesan Location, must have completed a volunteer application, background check, face to face interview and reference check.
- Application signed by your Pastor / Principal

Qualities of a Successful Safe Environment Trainer:

- *Comfortable speaking in front of large crowds*
- *Level headed when under stress*
- *Emotionally and psychologically stable*
- *Compassionate towards others*
- *Reasonably objective about sexual abuse*
- *Comfortable with discussing sexual issues*
- *Able to make a time commitment*
- *Able to maintain confidentiality*
- *Motivated to participate in the program*
- *Willing to attend annual training updates*

All trainers will participate in a **3 1/2 hours** training program that prepares one to lead safe environment training sessions at a Diocesan Location.
